INTRODUCTION

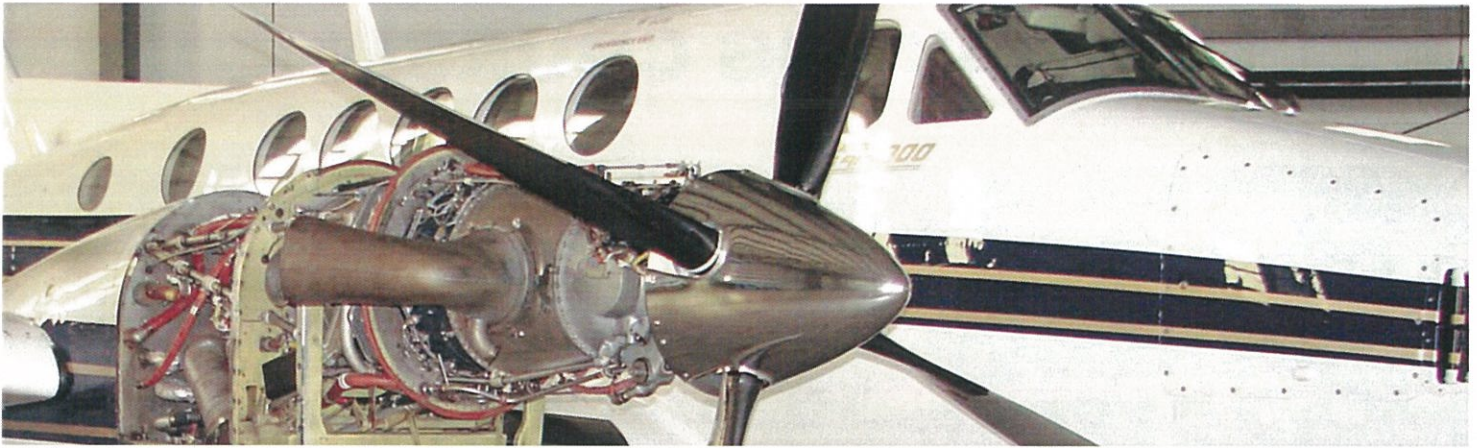

This course provides students with relevant knowledge and skills required to aid entry into the Aviation Maintenance Industry. Upon Successful completion of this course you will be awarded the nationally recognised qualification “Certificate II in Aircraft Line Maintenance” (MEA20515). Certificate II in Aircraft Line Maintenance is a complementary pathway into further qualifications within the Aviation industry. Students interested in studying Aircraft Maintenance Engineering or joining the Defence Force will benefit from this qualification.

COURSE DELIVERY

This course is delivered via E-learning online, distance assessment activities, written examinations and a final assessment activity with a qualified assessor. Part of the course will be able to be completed by distance; with the option of submitting assessments online or by post. The practical modules will be undertaken at one of our training facilities. The modules are sequenced in a way that allows a logical progression. Participants will be provided with professionally presented reference material to assist them in developing their knowledge of the subject.



COURSE DURATION

The program is designed to be delivered and completed in 12 - 15 months, however this may vary depending on previous experience. A longer duration may be chosen to allow students to maintain their normal work or study routine.
