ABOUT VOCATIONAL EDUCATION AND TRAINING

University is not for everyone. Vocational training is not for everyone. Education *is* for everyone.

Most careers need some form of education and training. But they don't all require a university degree. There are a variety of reasons your child or students should consider vocational education and training (VET). Perhaps they want to enter a trade, test out an industry, gain Queensland Certificate of Education (QCE) credits, or maybe they just need to improve or contribute towards their Australian Tertiary Admission Rank (ATAR).



The 2017 Perceptions Are Not Reality report from Skills Australia debunked some of the most common misconceptions about vocational education and training in Australia.



Almost 30 per cent of Australians believe that university graduates find work more easily than VET graduates.



VET graduates have a higher employment rate than university graduates. The average employment rate of a VET graduate is 78 per cent (it's 69 per cent for university graduates).

VET aims to provide the skills needed to keep up with our quickly changing employment and industry trends. Additionally VET provides courses for nine out of 10 occupations predicted to have the greatest growth of new jobs over the next five years.



Certificate IV in Crime and Justice is an accredited course. The Certificate IV in Crime and Justice is designed by justice professionals for people who would like to achieve employment in the criminal justice system and wish to develop a deeper understanding of the justice system.

Aims: The Certificate IV in Crime and Justice course is designed to:

- provide students with a broad understanding of the justice system
- · develop the personal skills and knowledge which underpin employment in the justice system.

Entry Requirements

Academic There are no formal entry requirements for this course. It is recommended that students have a pass in Year 10 English to demonstrate sufficient spoken and written comprehension to understand training material and to successfully complete all study and assessment requirements. Attitude – students need to demonstrate independent learning skills.

Learning experiences

Content is delivered via an online learning platform with support from the trainer and assessor. Technology required: access to the internet.

Pathways

The Certificate IV in Crime and Justice is recommended for students looking to gain employment or further study opportunities in justice and law related fields such as the police service, justice related occupations, corrective services, courts, legal offices, customs service, security industry and private investigations.

Course Costs

Full cost - \$700

This is a greatly reduced cost for school students and must be completed by the end of Year 12.

Qualification packaging rules

To attain this certificate, 10 units of competency (6 core and 4 elective) must be completed. These units are under the current National Training Package, however some elective units are subject to change prior to the commencement of the 2019 school year. This is to ensure alignment to current industry practices is at its optimum.



Further information

The course will assist in preparing students to continue onto a Diploma of Crime and Justice or a Bachelor of Criminology or a Bachelor of Justice.

Students will be required to attend 3 after school workshops held in the Unity College Lecture Theatre. Additionally, holiday catch up or get ahead days are offered on most school holidays.

Service Agreement

The RTO guarantees that the student will be provided with every opportunity to complete the Certificate IV in Crime and Justice as per the rights and obligations outlined in the enrolment process and subject information handbook provided. Students successfully achieving all qualification requirements will be provided with a Qualification and record of results. Students who achieve at least one unit (but not the full qualification) will receive a Statement of Attainment. This information is correct at time of publication but subject to change (June 2018).



WHAT ARE THE BENEFITS OF UNDERTAKING THIS QUALIFICATION?

When you complete the Certificate II in Tourism graduates will be qualified to apply for various positions including, retail travel agencies, tour wholesalers, tour operators, attractions, visitor information centres, cultural and heritage sites and any small tourism business requiring multi skilled employees. Job roles could include: Museum attendant, receptionist and office assistant in a tourism business, retail sales assistant at an attraction.

WHO IS ELIGIBLE TO PARTICIPATE?

All Queensland secondary school students in Years 10, 11 and 12 can access VET within any recognised qualification across a range of industries in a school environment; however VET investment funding can only be used for those qualifications identified as employment stream qualifications. Students who complete a certificate I or II level qualification at school are still eligible to access further Queensland Government subsidised training post-school such as Year 12 fee-free training and the Certificate 3 Guarantee. Students undertaking VETiS, which is resourced by the VET investment budget, will be funded to complete one employment stream qualification at the certificate I or II level.

Students will be required to complete a student training and employment survey within three months of completing or discontinuing the qualification.

WHAT ARE PARTICIPANTS AWARDED AT COMPLETION?

Upon successful completion of all units of competency in the course, participants will be issued with a Certificate II in Tourism SIT20116. Should a participant not complete the entire course then a Statement of Attainment will be given for the units successfully completed. Students who successfully complete the Certificate II in Tourism could progress to a wide range of other qualifications in the service industries. These include a Certificate III in Tourism SIT30116 and finally a Diploma of Travel & Tourism Management SIT50116. CTIA is responsible for quality training and assessment in compliance with the Standards for RTO (2015) and issuance of AQF qualifications.

Assessment is competency based, in that the participant will be required to demonstrate competency in a range of tasks. Vocational Education and Training in Schools



What is VETiS?

Vocational Education and Training in Schools (VETiS) is delivery of nationally recognised qualifications to school students, providing them with the skills and knowledge required for employment in specific industries.

VETiS qualifications can be undertaken in years 10, 11 and 12, and can count towards the Queensland Certificate of Education.

VETiS options

There are a variety of options available to students to undertake VETiS:

- as part of their school studies, delivered and resourced by a school registered training organisation (RTO)
- through fee-for-service arrangements where a parent/student pays for the qualification with an external RTO
- enrolling in a qualification with an external RTO which is funded by the Department of Education and Training's (DET's) VET investment budget.

Foundation skills required to complete a VETiS qualification are resourced by schools, regardless of how the qualification is funded.

School students can also undertake a vocational qualification through a school-based apprenticeship or traineeship (SAT), where students are employed while undertaking nationally recognised qualifications.

VETiS funded by the VET investment budget

DET's VET investment budget funds VETiS qualifications at certificate I and II levels that

have been identified in consultation with industry, and are based on national skills shortages, Queensland Government priorities and other evidence relating to effective training pathways that support employment.

These qualifications range across a number of industries and can be viewed by visiting the Queensland Training Subsidies List.

The VET investment budget provides funding for students to complete one VETiS qualification listed on the Queensland Training Subsidies List while at school.

Students are able to undertake any qualification while at school, however students wishing to access the VET investment budget for certificate III qualifications should do so as a SAT.

Other certificate III qualifications may be delivered and funded outside of the SAT pathway, subject to the submission of an Industry Proposal Funding Submission that outlines localised arrangements between schools and employers.

Such arrangements are a key feature of high quality VETiS.

For a certificate III qualification to be considered for VET Investment funding, submissions must demonstrate:

- local arrangements brokered between employers and schools for employment of VETiS graduates, with evidence of employer consultation
- employers guarantee employment of successful VETiS graduates



consultation with DET regional offices and schools.

Choice of RTO

Schools and students undertaking VETiS funded by the VET investment budget will be able to choose any RTO approved by DET as a pre-qualified supplier (PQS) under the Certificate 3 Guarantee for the eligible qualification.

The final choice of RTO and arrangements for enrolment with the selected RTO should be made by the school, in consultation with students and their parents.

PQS and schools who enter into arrangements for the delivery of VETiS are encouraged to articulate each party's roles, responsibilities and expectations in a formal agreement.

A list of PQS approved to deliver each subsidised qualification is published on the Queensland Skills Gateway.

Under the PQS system, funding follows the eligible student to their chosen PQS and is paid directly to the PQS on submission of the student's validated training data.

RTOs that wish to deliver VETiS (funded by the VET investment budget) can visit the Training website for further information on how to become a PQS.

Fees

VETiS funded by the VET investment budget must be fee-free for students. The government determines the level of subsidy available as a public contribution to the cost of the training, and provides the maximum subsidy for VETiS students in most circumstances. It is intended that the level of subsidy for each VETiS qualification should cover the costs associated with participating in the training.

However, in some instances there may be a shortfall between the subsidy level and the fees charged by the PQS, which is referred to as a co-contribution fee, and this cost is paid by the school to the PQS.

A PQS must disclose its fees upfront and clearly publish them on their website. This allows schools and students to be informed of all training costs and to compare co-contribution fees (if any apply) across different PQS.

Certificate 3 Guarantee and fee-free training for Year 12 graduates

Regardless of how it is funded, participation in VETiS or a SAT does **not** affect a student's access to fee-free training for Year 12 graduates or subsidised training post-school through the Certificate 3 Guarantee — even if the student has completed a certificate III level qualification at school.

COMMITMENT CONTRACT

If your training organisation created a USI for you, they cannot activate your USI account. You can activate your account by:
